

TENDER NOTIFICATION

2. No Tenderer can quote value less than the minimum value of work. The Tenderer who holds PF, ESI Code and valid labour licence under Contract Labour (Regulation & Abolition Act, 1970), GST Number & Firm Registration with the appropriate authority will be given preference.

The Tender Forms together with Terms & Conditions are available in the Depot Manager's Offices (ADB, ASF,BNS,MNCL,NRML & UTNR) of Adilabad Region from 10.11.2022 to 21.11.2022 on payment of Rs.1180/- including 18% GST in A-Class Bus Station(Nirmal), Rs.885/-_including 18% GST for ADB, ASF,BNS & MNCL Bus Stations, and Rs.295/-including 18% GST for Bellampally, Kagaznagar, Mudhole, Basar, Luxettipet, Jannaram,Chennur, Khanapoor, Boath and Utnoor Bus Stations. The DD has to be drawn in favour of Accounts Officer, TSRTC, Adilabad Region.
4. Sealed tender forms duly filled in shall be dropped in the sealed tender box kept in the office of the Regional Manager, Adilabad upto 14.00 hrs on 22.11.2022 and the same will be opened at 15:00 hrs on the same day in the presence of the Tenderers or their authorized Representatives.
5. The tenderers those who purchased the tender form have only to submit the tender form, otherwise, the tender will be rejected. The tender has to enclose a copy of his PAN Card/GST Registration.
6. The family members and closed relatives of TSRTC employees, directly or indirectly are not permitted to participate in the tenders.
7. The Contractors whose past credentials are not good and involved in serious irregularities in respect of statutory benefits/ payment of wages and under block list shall not be permitted to participate in the tenders. In case of participation, their tenders will be rejected summarily on that ground alone.
8. The detailed "Terms and Conditions" relating to the above-mentioned work contract will be supplied along with the Tender Form / Application.
9. The Corporation reserves rights to reject any or all the tenders & postpone without assigning any reasons.
