04. The filled in Tender form shall be submitted in the Tender box in the Office of the RMs Office, TSRTC, KMM from 10.30 Hrs up to: 14.00 Hrs. on 03-04-2024 and the box will be opened at 15.00Hrs on the same day in presence of the tenderers or their authorized representatives.
05. In case EMD paid by the tenderer is less than what is stipulated in the tender notification or the EMD paid through other means i.e. in a manner other than the stipulated terms and conditions, the tender will be rejected besides forfeiting the EMD.
06. In case the amount offered is less than the amount mentioned in the Tender Notification, the tender form/application will be rejected since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. Other things being equal, if more than one Tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY. The Contractor must have PF/ESI registration and it will be renewed with valid date. Further, the Labour license obtained in respect of shops and establishment is not acceptable. The form VI issued by the Dy. Commissioner of Labour / Asst. Commissioner of Labour shall invariable enclosed for verification. (Wherever applicable).
07. The Tenderer has to enclose a copy of his PAN CARD, GST NUMBER, Aadhar Card, PF, ESI, Labour license etc., without fail.
