  - e) Caste certificate Xerox for reserved stalls.
  - f) Aadhar card Xerox copy.
  - g) PAN card Xerox copy
  - h) GSTIN registration number Xerox copy.
  - i) The interested parties who apply for tenders may inspect the premises before submitting the Tender Form duly contacting the Depot Manager of the respective Depot.
- The bidder has to pay the Earnest Money Deposit (EMD) amount and Processing Fee DD as 6. notified in the Auction Tender notification by way of Demand Draft in favour of "Accounts Officer, T.S.R.T.C., Nalgonda" and DDs shall be submitted along with Tender form. Failure to enclose the DDs to the tender form will be rejected. The EMD amount shall not carry any interest.
