TERMS AND CONDITIONS

01. The period of contract is Two years and further extendable for one more year based on the satisfactory performance.
02. The Tender forms along with the terms and conditions of work contracts can be obtained from the offices of the Depot Managers and CRM/MGBS on payment of the following rates on all working days from **28.10.2022 at 10.30 HRS UPTO 12.11.2022 at 17.00 HRS.**

01. The EMD amount shall be drawn through Demand Draft only Draft with Nationalized Bank drawn in favour of **“Dy. CHIEF ACCOUNTS OFFICER/RR, HYDERABAD”** and the Original DD shall be submitted along with Tender forms. Failure to enclose the Demand Draft to the tender form will be rejected and EMD enclosed less than the stipulated amount in

the Tender Notification, or the EMD paid through other means, the tender will be rejected besides forfeiting the EMD to the Corporation. **The EMD shall not carry any interest.**

02. The EMD amount of un-successful bidders will be refunded after finalization of tenders, without any interest.
03. The Tender form duly filled in all aspects and sealed shall be placed in the Tender Box kept in the office of the Regional Manager, TSRTC Rangareddy **from 10.30 Hrs upto 14.00 Hrs on 14.11.2022 and the box will be opened at 15.00 Hrs, on the same day in the presence of tenderers or their authorized representatives. The name of the work contract and place of work shall invariably mentioned on the cover.**
06. Tenders are invited from the Individual/Man Power Agencies Registered with the **Labour Department with valid License** to provide Safai Karamcharis required to carry out for maintenance Sewerage, Soil, Bathroom and Latrines and other similar type of works.
07. The remuneration for providing Safai Karamcharis works with PF, EDLIF, ESI & 7% Profit Margin are included in tender notification. If the quoted is less than the above will not be accepted in the tenders.
08. In case the amount offered for maintenance of Toilets is less/more than the amount mentioned in the Tender Notification, will be rejected, since the value of Contract amount includes the Minimum Wages, PF/ESI with profit Margin. Other things being equal, if more than one tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTARY. The contractor must have PF/ESI/GST registration and shall be renewed with valid date. Further the labour licence obtained in respect of shops and establishment is not acceptable, the Form VI issued by the Dy. Commissioner of Labour/ Asst. commissioner of labour shall invariable enclosed for verification (wherever applicable). Tenderers, those who purchase the Tender Form, has only to submit the tender form. Otherwise the tender will be rejected. The tenderer has to enclose a copy of PAN CARD Aadhar, PF, ESI, valid Labour licence and GSTIN registration number.
09. The Tenderer should submit separate tender form for each tender along with DD/Cheque for requisite EMD. Otherwise the tender will be rejected.
10. Other things being equal, the tenderer who is holding PF and ESI Code Nos. and Labour Licence issued by the concerned authorities shall be given preference.
11. The Contractor/Agency has to quote individual applications for each contract.
12. The No.of Workers to be engaged may be increased / decreased based on the necessity for maintenance of Bus Station work.
13. The family members and close relatives of TSRTC Employee directly or indirectly are not permitted to participate in the tenders.
14. The contractors whose past credentials are not good and involved in serious irregularities/ mis-appropriation etc., in respect of statutory benefits/payment of wages and issued with notices for block listing/block listed shall not be allowed to participate in tenders. In case of participation, their tenders will be rejected summarily on that ground alone.
15. The Corporation reserves the right to accept/reject any / all tenders without assigning any reason. For any further information/ clarification please contact RM's Office, Rangareddy.
