TERMS AND CONDITIONS:

01. The prescribed Tenders forms can be obtained from the concerned Depot Manager's Offices of Medak Region in all the working days during Office Hours **from 27.10.2022 to 11.11.2022**, duly paying the cost of tender form as applicable mentioned below.
02. The cost of the Tender Form is Rs.885/- (750 + 135 GST)
03. The EMD amount shall be drawn through Demand Draft only in favour of **ACCOUNTS OFFICER, TSRTC, MEDAK REGION, SANGAREDDY**. In the event of EMD enclosed is less than the stipulated amount in the Tender Notification, it shall be forfeited to the Corporation. The EMD shall not carry any interest. The EMD amount of unsuccessful bidders will be refunded after finalization of tenders, without any interest.

04. The sealed cover containing filled in Tender form in all respects addressed to Regional Manager, T.S.R.T.C., Medak Region at Sangareddy shall be dropped in the Tender box in the Office of the Regional Manager's Office, TSRTC, Medak Region, # Trinethra Complex, 2nd Floor at Sangareddy from 10.30 hrs upto:14.00hrs. on 11.11.2022 and **the box will be opened at 15.00 Hrs** on the same day in presence of the tenderers or their authorized representatives. **The name of the work contract and place invariably mentioned on the cover.**
05. Tenders are invited from the individuals/Man Power Agencies Registered with Labour Department with valid license to provide Safai Karmacharis required to carry out for maintenance Sewerage, Soil, Bathroom and Latrines and other similar type of works. The remuneration for providing Safai Karmacharis works with PF, EDLIF, ESI and 7 % profit margin are included in the tender Notification. If the rate quoted is less than the above will not be accepted in the tenders.
06. In case the amount quoted is less than the amount mentioned in the Tender Notification the tender will be rejected, since the value of Contract amount includes the Minimum Wages, Statutory benefits (PF, EDLIF & ESI) with profit Margin. **Other things being equal, if more than one tenderer quotes same rate and found suitable by the Tender Committee, the Contract shall be allotted on the basis of LOTTERY.** The Contractor must have PF, ESI registration and GST No. (wherever applicable).
07. Tenderers those who purchases the Tender Form, shall submit the tender form on their name only, other-wise the tender will be rejected. The tenderer has to enclose a copy of his PAN CARD & Aadhar Card & GSTIN registration number.
08. The tenderer should submit separate tender form for each tender along with Demand Draft for requisite EMD, other-wise the tender will be rejected.
09. Other things being equal, the tenderer who is holding PF, ESI code Nos. Labour License and GST No. issued by the concerned authorities shall be given preference.
10. The contractor/Agency has to quote individual applications for each contract.
11. The No. of workers to be engaged may be increased / decreased based on the need/ circumstances
12. The detailed Terms and Conditions relating to the above mentioned work contract will be supplied along with Tender form / Application.
13. The family members & close relatives of TSRTC Employee directly or indirectly are not permitted to participate in the tenders.
14. **The contractors whose past credentials are not good and involved in serious irregularities / mis-appropriation etc., in respect of statutory benefits / payment of wages and issued with notices for block listing / block listed shall not be allowed to participate in tenders. In case of participation, their tenders will be rejected summarily on that ground alone.**
